TRACT 1: A TRACT OF LAND SITUATED IN THE SE/4 OF SECTION 11, T22N, R9W.I.M., MAJOR COUNTY, OKLAHOMA MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID SE/4; THENCE NORTH (N00°01'15"E), ALONG THE EAST BOUNDARY OF SAID SE/4, A DISTANCE OF 1767.34 FEET TO THE POINT OF BEGINNING; THENCE WEST (N89°03'54"W) A DISTANCE OF 976.69 FEET; THENCE SOUTH (S01°51'17"W) A DISTANCE OF 377.83 FEET; THENCE SOUTHWESTERLY (S55°49'22"W) A DISTANCE OF 555.08 FEET; THENCE NORTHEASTERLY (N17°01'20"E) A DISTANCE OF 482.02 FEET; THENCE NORTH (N00°17'58"E) A DISTANCE OF 539.35 FEET; THENCE WEST (N89°16'58"W) A DISTANCE OF 400.85 FEET; THENCE NORTH (N00°54'22"E) A DISTANCE OF 544.35 FEET TO A POINT ON THE NORTH BOUNDARY OF SAID SE/4; THENCE EAST (S89°40'43"E), ALONG SAID NORTH BOUNDARY, A DISTANCE OF 1696.63 FEET TO THE NORTHEAST CORNER OF SAID SE/4; THENCE SOUTH (S00°01'15"W), ALONG THE EAST BOUNDARY OF SAID SE/4, A DISTANCE OF 866.52 FEET TO THE POINT OF BEGINNING, SAID TRACT CONTAINING 34.92 ACRES.
