and to all of the oil, gas and other minerals in and under and that may be produced from the following described lands situated in Woodward County, State of Oklahoma, to-wit:

S/2SE/4 and E/2SW/4 of Section 31, Township 22 North, Range 18 WIM
S/2SW/4 of Section 32, Township 22 North, Range 18 WIM

containing 357.67 acres, more or less, together with the right of ingress and egress at all times for the purpose of mining, drilling, exploring, operating and developing said lands for oil, gas and other minerals and storing, handling, transporting and marketing the same hereafter with the right to remove from said land all of Grantee's property and improvements.

For the same consideration the conveyance hereby transfers any and all rights of the grantor, to any rentals, royalties, bonuses, and other benefits accrued prior to this date, but which are now held by any purchaser or entity for production from any well located on the captioned premises or any unit connected therewith.

Grantor agrees to execute such further assurances as may be requisite for the full and complete enjoyment of the rights herein granted and likewise agrees that Grantee herein shall have the right at any time to redeem for said Grantor by payment, any mortgage, lease, or other liens on the above described lands, upon default in payment by Grantor, and be subrogated to the rights of the holder thereof.

TO HAVE AND TO HOLD The above described property and easement with all and singular the rights, privileges, and appurtenances thereunto or in any wise belonging to the said Grantee herein his heirs, successors, personal representatives, administrators, executors, and assigns for ever, and Grantor do ES hereby warrant said title to Grantee him heirs, executors, administrators, personal representatives, successors and assigns forever and do ES hereby agree to defend all and singular the said property unto the said Grantee herein his heirs, successors, executors, personal representatives, and assigns against every person whomsoever claiming or to claim the same or any part thereof.


