Grantor agrees to execute such further assurances as may be requisite for the full and complete enjoyment of the rights herein granted and Grantee agrees that Grantee herein shall have the right at any time to redeem for said Grantor by payment any mortgage, lease, or other liens on the above described land, upon default in payment by Grantor, and be subrogated to the rights of the holder thereof.
